- Frontier Border Locations have chosen a Border Control Model. Meaning the type of declaration, depends on where your goods are arriving into/ departing from.
- You must have supplier origin declarations (where required) at the time you import/export your goods.
- Commodity codes have changed, you must check trade tariff to ensure your tariff code is still valid.
